THE PRODIGAL (DAUGHTER) RETURNS

God is the Creator, the Designer, the Artist. He rescues men at all stages of life and various degrees of sin and welcomes them into His Kingdom as adopted sons and daughters. All this is done through the person and work of His Beloved Son, Jesus. In the future, those of us who belong to Him will see the end result: a vivid tapestry of redeemed lives singing praises to the King and knit together as the radiant Bride of the Lamb, spotless and pure.

If all the threads of this tapestry were of the same hue, we would not see the depth and breadth of God's love, mercy and grace. However, in His infinite wisdom He has called to Himself a rich blend of people and lives that together glorify Him to the utmost.

One special thread in this great painting of the King we'll call Stephanie*. Stephanie is a great lover of King Jesus and seeks to honor Him with a life that is reflective of His love and obedient to His Word. As with all of us who have been saved from the miry pit, this has not always been the case.

Growing up in the Pacific Northwest with her parents and three siblings, life dealt difficult blows early on. The death of a new baby sister when she was 9 years old was a defining moment for her family. Her mother devastated by this loss slipped into the world of spiritual/emotional despondency. This inclined the already hardworking, yet often absent father to retreat even more from the family. The eldest daughter began to runaway from home, and Stephanie soon followed her example seeking solace in the streets. The time was the mid 1960s, but the story is as familiar as the tale of runaways today.

At twelve years old she began the cycle of running, spending some time on the streets, getting picked up by the police and being sent home. After a couple of weeks she would be off again. By the time Stephanie was 13, with several stints of running away to the streets already behind her, the juvenile court system removed her from her parents' home and placed her into the foster care system in an effort to solve the problem. It only worsened. She continued to run hanging out with street thugs who were involved in drugs, prostitution and crime. After two foster homes, which introduced her to the world of physical and sexual abuse, and being the victim of a brutal gang-rape by some on the streets she was remanded to the "state school for girls" better known as the Hillcrest

Juvenile Correctional Facility. In two short years, Stephanie had gone from a youngster running away from a difficult home life to a teenager involved in drugs and prostitution whose trust had been violated repeatedly and who threw off any authority. Despite attempts to "reform" her even to the drastic measure of medicating her with the antipsychotic drugs thorazine and prolixin, she continued to runaway this time from the school. At 16, a school staffer took Stephanie into her home as a foster child. However, after about a year she got into great legal trouble within the community. Back at Hillcrest while the courts decided her fate she learned that even they didn't want her. Deemed incorrigible, she was emancipated from the state prior to her eighteenth birthday. Housed at a YWCA she worked at a job that was provided for her during her recent foster care stint, went to school at night to get a high school equivalency diploma and partied on the weekends.

Settling into a routine, Stephanie lived what she'd call a "square life" for the next several years. This life included working, partying with her crowd and hustling at "nice" hotel bars for some extra cash. At 23 Stephanie gave birth to a son. Though she didn't live with the child's father they did have an ongoing relationship. After awhile it turned violent and she opted out. That is how she ended up in Minnesota. With some friends here from a six-month visit in the early seventies, Stephanie and her son relocated to the Midwest in 1980. She continued in the same vein: work, party, hustle. Cocaine was introduced into the picture and in two short years she was regularly using coke and turning tricks fulltime involved even to the degree of operating her pimp's escort service while he was doing time in prison. Throughout this period babysitters, daycare workers and schoolteachers were raising her son.

In 1984, Stephanie found herself pregnant, prostituting and nursing a heavy coke habit. Her friends from the street kept telling her she needed to quit because of the baby, some of her regular dealers stopped selling to her for the same reason. Even her physical health was in decline; a doctor's report of her lung capacity indicated that it was 30% lower than it should be. As one of the Puritan's once said, "The Lord breaketh all men's hearts differently." God was about to begin tugging on Stephanie's heartstrings in a more overt way for the first time in her life. A middle of the night cry, "God, if you let this baby inside of me be born OK; I'll stop doing everything I'm doing," was her first reach out to Him. Of course, it wasn't the cry of a repentant sinner seeking forgiveness, but it was an acknowledgement of the Creator and an implicit understanding to some degree that how she had been living her life was wrong. The following day by God's great grace she dumped her cigarettes, stopped using and told the escort services to "stop paging me because I'm leaving the business." Shortly thereafter she got a job, went through a transition program and delivered a healthy baby girl at the end of the year.

As the new year, 1985, began she was home on leave from work for the new baby. The Lord sent a Pastor and his wife who were former missionaries to Japan, now living and ministering in North Minneapolis, to Stephanie's door. They had met her son while he was playing outside a few days earlier and came back to meet and talk with his mom. The pastor would come to her home and read with her through the gospel of John. Through this time of reading the Word and asking questions about it, the Holy Spirit revealed the truth of the saving gospel of Jesus Christ to Stephanie. She began to see clearly her sin and her need for a Savior. One of these visits she prayed with the pastor confessing a litany of past sins and asking God for forgiveness through Jesus. The angels rejoiced as a daughter of the King came home!

So what now??? Was everything "happily ever after" for Stephanie, her son and daughter? Has she been having a 22-year upward, smooth sailing walk with the Lord? Well, in this fallen world influenced by Satan, marred by sin and our flesh which wants its own sinful propensities to be fed, the answer is no. It has been a hard, spotty, road for Stephanie. For the first five years of this new life in Christ, she walked the walk. She worked hard at her job, raised her kids, and went to church. Feeling like she didn't fit in with the typical congregant, she struggled. Soon attending college seemed like it would be the answer to her outcast status. Very involved with ministry and successful in her studies, she began to get puffed up with knowledge and her own abilities. The pressure from all these self-created expectations and those of others coupled with overextending herself and leaning on her own understanding and strength conspired with the repetitive nightmares she was suffering, which brought vivid, mocking images from her past life into her thoughts, needed an outlet. The choice would be either to lay them all at the feet of the One who could help her overcome or be tempted, dragged away and enticed by her own evil desires (James 1:14). Succumbing to the temptations of her former lifestyle, Stephanie fell and began a new, 16-year battle with her flesh.

During this period she battled drugs, crack this time, selling herself again on the streets to support her growing habit. Her children went in and out of the foster care system often in the custody of brothers and sisters from the church. As her teenage years were filled with the repetitive cycle of running away, so her baby Christian years were mirroring that with the relapse/recovery cycle of this lifestyle. The longest period of clean time she had during this season was 18 months. In 1994, four years into this backslide, Stephanie had a brief stay at Teen Challenge Minnesota. Though she didn't remain in the program at

Now a grandma with two grown children and three grandkids, Stephanie is eager to serve the Lord and minister His love and grace to her family and to hurting souls who are still lost and traveling down the broad road. Pray that we in our relations with her would be a means of encouragement, growth and blessing.


